2- BSAC work priorities

The BSAC has identified 7 work priorities:

1. Fish stock sustainability: fishing opportunities recommendations.
2. Fisheries management, improving the regulations and their implementation: Common Fisheries Policy, Landing Obligation, Technical Measures Regulations, Control Regulation.
3. Ecosystem approach, species interactions and environmental policies.
4. Climate change and fisheries.
5. Fisheries as a sustainable, protein-rich seafood.
6. Socio-economic dimension of the CFP and recreational fisheries.
7. Regionalisation, cooperation, communication.



2. BSAC work priorities



BSAC work priorities: horizontal issues for all Working Groups

- Recommendations on fishing opportunities for 2026.
- Evaluation of the CFP
- Follow the implementation of the Commission Marine Action Plan to conserve fisheries resources and protect marine ecosystems and of BSAC recommendations on the topic.
- Recreational fisheries: Towards a balanced and proportionate policy for recreational fisheries under the Common Fisheries Policy, work will include measures to strengthen reporting and data collection from recreational fisheries.
- Management of seals and other predators and interactions with fisheries
- BSAC Science Focus Group
- OCEAN PACT

2. BSAC work priorities




Follow up on the letter to ACOM Chair, asking for a change in the format of advice presentation

The BSAC asked for ICES advice to be presented directly upon release with experts present to answer more specific questions

The BSAC is in consensus that receiving information early in the advice development process—and directly from those who conducted the assessments—would provide significant added value.

2. BSAC work priorities

- **Follow up on the letter to ACOM Chair, reply received from ACOM Chair**



The experts contributing to ICES work are not individually responsible for the ICES advice nor is their time controlled or supported by ICES. So, what you propose is something that ICES can implement.

ICES could reach out to the relevant experts and explore their capacity and willingness to attend. ICES could review and have further dialogue before the advice release next year.

BSAC Science Focus Group will discuss how to improve the current advice framework.

. BSAC work priorities

- **BSAC Science Focus Group:**

A newly established group where we will create consensus suggestions on how to improve co-operation between science and management from a Baltic fisheries perspective.



. BSAC work priorities

- BSAC recommendations on energy transition



The BSAC will review its recommendations published in 2023, in the light of the new developments in the framework of the Energy Transition Partnership.

BSAC plans to reactivate its Energy Transition Focus Group- for this purpose

2. BSAC work priorities

Demersal Working Group, chair Teija Aho

- Developing a cod recovery plan. Structure, components and goals to be discussed in the autumn demersal working group.
- Salmon in collaboration with the EBM WG (HELCOM recommendation, Baltic Salmon Management Plan).
- Further discussions related to the predator management (draft European cormorant management plan)



2. BSAC work priorities



Ecosystem-based Fisheries Management Working Group, chair Matti Ovaska

- The Marine Strategy Framework Directive: ongoing review, including working on descriptors that are relevant to fisheries.
- Integrated sea use management/maritime spatial planning: continue working in particular on offshore windfarms developments.
- Ecosystem approach, species interactions and environmental policies: Marine Action Plan, eel.
- Salmon in collaboration with the Demersal WG (HELCOM recommendation, Baltic Salmon Management Plan, information on new studies on natural mortality and species interaction e.g. salmon and herring)
- How to better incorporate the EBM into the scientific advice. BSAC is currently drafting **“Advice on implementation of Ecosystem Based Fisheries Management in the Baltic Sea”**

2. BSAC work priorities

Pelagic Working Group, chair Lise Laustsen

- Investigate further work on management of the western Baltic spring spawning herring
- Bothnian bay herring, closely follow scientific analysis and measures proposed, and if relevant, give advise other herring stocks.
- Follow up on stickleback and trial fisheries in the Baltic
- Work on species interactions between sprat, herring and cod (in close cooperation with the Demersal WG)
- Discuss how to improve the data collection in pelagic fisheries.


- **The recommendations** were developed after the presentation of the ICES advice by ICES Vice-Chair of ACOM, Dorleta Garcia, and the following discussions, at the Joint Working Group held on 17th June 2025 and the Executive Committee meeting on 26th June 2025. **The recommendations were agreed in July 2025**



The recommendations focus on the limitations in the current scientific advice, the importance of diverse factors affecting fish stocks as well as the mixed fisheries and selectivity issues.





Coming Activity

- **BSAC Discussion of allocation of EMFAF funds.** The BSAC will draft a letter to BALTFISH regarding the allocation of EMFAF funds for the post-2027 period, highlighting Baltic Sea priorities. This was a joint initiative from the Advisory Councils as a response to the Commissions' communication "The road to the next multiannual financial framework"
- **Energy Transition** –updated recommendation from the BSAC, to be discussed and adopted in a dedicated session of the **Energy Transition Focus Group** or ExCom meeting in the autumn 2025.
- **BSAC 20th Anniversary** – The major event would take place at the **ExCom in May 2026**. A special workshop or seminar summing up the work of the BSAC in 20 years could take place during the **ExCom in January**, to be held in Gothenburg (TBC), the capital of the BALTFISH Presidency.
